When Taking Medication is a Sin: Religious Traditions and the Presence of Animal Products in Medications

The cultural backgrounds of patients cared for by health care professionals in the United States is becoming increasingly broad and varied. In keeping with our tradition of respecting the religious beliefs of other persons, it is important that caregivers familiarize themselves with the ever-widening range of cultures and beliefs of the persons whom they work to heal. Illness is in many respects and for many persons a spiritual event. This discussion of the presence of animal products in medications opens the door to a more comprehensive understanding of and respect for the religious beliefs and values of those to whom we are pledged to provide care.

Objectives

Participants will be able to:

- 1. explain why the manufacturing process of medications requires the presence of animal products;
- 2. discuss the importance of understanding the religious traditions of the patient to the clinician-patient relationship;
- 3. integrate into the consent process they currently use, as clinicians and as researchers, the issue of whether patients have a religiously-based objection to animal products in medications;
- 4. discuss with their patients alternatives to the use of medications containing animal products and ways of obtaining counseling about their religious beliefs in relationship to the need for such alternatives.
